



ROYAL DECREE 2022/1

Ratifying the State's General Budget For Fiscal Year 2022

We, Haitham bin Tarik, the Sultan of Oman

after perusal of the Basic Statute of the State, and the Financial Law promulgated by Royal Decree 98/47, and after presentation to Majlis Oman, and in pursuance of public interest,

Have decreed as follows

Article I

The State's General Budget for Fiscal Year 2022 is hereby ratified in accordance with the attached schedules.

Article II

All units of the State administrative apparatus and other public legal persons shall implement the provisions of this decree each within its competence.

Article III

This decree shall be published in the Official Gazette, and comes into force on 1 January 2022.
